

Josephine County Intergroup Meeting Minutes December 19, 2024

Meeting was opened at 7:05 with the Serenity Prayer.

Secretary Report: Jessica read November's minutes. The two suggested amendments were to add Maria to the attendance and to correct the time of the Juggernauts meeting to read 6:00. Stephanie motioned to accept the minutes as amended, Alison 2nd, approved.

Treasurer Report: Contributions for the month of November totaled \$1,069.87. November's net revenue was \$28.89. Jessica motioned to accept the Treasurer Report as presented, Stephanie 2nd, approved.

Office Manager Report: All volunteer shifts are covered. Ads relevant to AA have been approved and are being printed in the Rogue River Press and will be printed in the Illinois Valley Times.

Events Report: The Thanksgiving Day dinner was well attended. Sign up sheets for the marathon meetings to be held on Christmas and New Years have been posted at the Hi-Lo Club.

Jail Report: Women volunteers to bring meetings into the jail are still needed, as is a service position of a female jail scheduler.

Literature Report: Joey reported that the invoicing of documents is going well. The Plain Language Big Book is currently sold out and is on backorder awaiting the printing of the 2nd edition.

Newsletter Report: The newsletter for Nov/Dec is still out in circulation and the next one will be out for Jan/Feb.

Web Servant Report: The events page was updated to include the marathon meetings. The service opportunities have been updated and is downloadable to share with groups. There was a 50% increase in the traffic to the events tab.

Office Volunteer Coordinator Report: All positions are currently filled and things are going well.
