

Josephine County Intergroup Meeting Minutes January 16, 2025

Meeting was opened at 7:00 PM with the Serenity Prayer.

Secretary Report: Jessica read the minutes from December, suggested change was to correct the Sobriety Rocks 12x12 study to Tuesdays at 5:30. Alison motioned to approve the minutes with the noted change, Sheri 2nd, approved.

Treasurer Report: For December there were contributions in the amount of \$743.65 and a net revenue of \$590.49. YTD contributions were \$12,896.99. YTD expenditures were \$10,881.40 leaving about \$2,000 for events for the year. Jessica motioned to accept the Treasurer report, Steph 2nd, approved.

Office Manager Report: There are open office volunteer shifts of the 1st and 3rd Mondays 1-4, Tuesdays 1-4, and the 2nd, 4th, and 5th Fridays 10-1. Looking into less expensive options for the answering service.

Events Report: We are in the process of evaluating future events. Discussing with the banquet coordinator at TapRock to possibly bring in our own desserts for the Spring Fling.

Jail Report: Please make the announcement at meetings that we need a female jail scheduler to coordinate the women volunteers.

Literature Report: Joey wasn't able to be present but his report was read. The Bend Central Office closed so orders from that area will be coming through Josephine County Central Office.

Newsletter Report: The January/February newsletter is out.

Web Servant Report: Alvin is working on being able to distribute the Newsletter digitally.

Office Volunteer Coordinator: This is a vacant position. The suggested sobriety requirement is 2 years clean and sober and to have worked the steps.
